**Abstract**

The Philadelphia Federation of Women's Clubs and Allied Organizations, Inc., was organized in 1922 and was affiliated with the Pennsylvania Federation of Women's Clubs, which had been in existence since 1895. Its objectives, as stated in its Charter and By-Laws, were "to unite Women's Clubs and other organized groups of women existing in Philadelphia and adjacent territory for purposes of mutual benefit and to promote their common interests in civic, educational and moral measures which make for individual and community welfare."

The clubs constituting the federation had varying objectives, but all aimed to serve some segment of the community. The federation made it possible for them to join together for shared agendas and for a stronger voice beyond their individual memberships. The presidents of the clubs formed the backbone of the federation's operation under the guidance of its board and elected officers.

The records of the organization are concentrated in banking and other financial activities associated with managing its affairs. There is also substantial material on a public forum presented by the federation in the midst of World War II to consider planning for postwar U.S. world positioning.

**Background note**

The Philadelphia Federation of Women's Clubs (PFWC) was organized at the end of 1922 (and incorporated in 1940) as an umbrella group for women's clubs, both senior and junior, active throughout the Philadelphia area. The federation had its first headquarters at Gimbel Brothers, and later moved to the Engineer's Club at 1317 Spruce Street. It was a member of the Pennsylvania Federation of Women's Clubs and of the National Council of Women.

The local clubs were formed at different times to serve a variety of objectives, but were all built around community service. The PFWC brought them together for the benefits gained through regular meetings and shared activities and events. The common thread was the engagement of women in the life of their communities and

creating support in whatever way they could for issues of their choosing. The federation made it possible for them to represent and speak for their local interests as well as to join together to participate in a broader agenda of issues for the Philadelphia area as a whole. In an age of limited public life, public expression, and public recognition for women, they were able to develop, test, and use their organizational, administrative, and planning skills during some seventy years of active participation. It was a productive effort with an admirable record of continuity until 1993, when a drastically reduced active membership (from over a hundred member clubs in 1949 to less than fifty by 1990) forced it to disband. Despite this, however, the federation was left with enough funds to support several charitable functions into the late 1990s.

The PFWC functioned within the guidelines of by-laws drawn up by the organization's board, which consisted of its officers and chairs of standing committees, and was supported by the extended board of presidents of the constituent organizations. It conducted itself much like a small business enterprise and benefited from many leaders with strong organizational and management skills. Most of the clubs were largely governed by their own by-laws.

The federation showed greatest strength from the early years through the 1970s, by which time the growth of opportunities for women in the community at large as well as the rapidly increasing participation of women in the workplace seems to have made serious inroads into women's organizations. As their numbers dwindled, so did participation in the PFWC.

The federation pursued some activities for a substantial period, such as annual teas, fundraising sales of various sorts, and special efforts to provide fellowships and scholarships for nursing training. But the outstanding activity in the federation's history was its 1943 event billed as the Women's Forum. It was sponsored jointly with Gimbel Brothers – a major force for charitable work in the Philadelphia area at the time – and represented the Federation's most notable accomplishment in the public arena. On behalf of its 130,000 members, it staged a full-day public forum for postwar planning and to assist in determining what the U.S. position should be in international reorganization. In effect, the PFWC posed the question of how the U.S. should shape postwar world organization prior to the formation of the United Nations, and what the role of the U.S. should be in any related planning. Organizing the event was a major undertaking and illustrated the energy, self-confidence, and formidable organizing ability of the women involved.

## **Scope & content**

This small collection of records from the Pennsylvania Federation of Women's Club's and Allied Organizations (PFWC) has been divided into three groups: administrative records, financial records, and records from the 1943 Women's Forum for Post-War Planning. Spanning six boxes, these papers date from the 1940s to the 1990s, and offer limited insights into the club's planned activities, daily

operations, and financial standing. Each group of material has been arranged chronologically.

Among the administrative records are the PFWC by-laws, lists of board members, board meeting minutes, annual reports, and club membership applications. The applications contain scant details on constituent clubs, records of dues paid by the clubs, and the years during which many of them were active members. Additional papers include those relating to fundraising and giving activities, such as the club's 1998 Avenue of the Arts Bell Project and its nursing scholarship. There is also a folder of correspondence between the PFWC and various local and federal officials on federal excise taxes and appointment endorsements. The series also contains issues of PFWC's newsletter dating from 1980 to 1993; papers on special events, such as a 1978 seminar on crime reduction; and reports of meetings on women's issues sponsored by UNESCO and the World Affairs Council.

The banking and financial records span from the 1950s to the 1990s and include bank statements, deposit slips, check stubs, bills and receipts, and treasurer's reports. The group also contains two folders pertaining to dues owed by clubs that held memberships with the PFWC.

Comprising the final group of records are those from the 1943 Philadelphia Women's Forum for Post-War Planning, held 2 April 1943 at Philadelphia's Gimbel Auditorium. This event was sponsored by PFWC and the Gimbel Brothers, and was intended to prepare attendees for life after the Second World War. It included a variety of educational presentations, such as "Preparation for a Dynamic Peace," "Russia—Our Partner in Victory," and "When a Woman Looks at Post-War Planning." Plans for this event were based on PFWC's ambitious intentions to reach women in the upper echelons of government and public life, including First Lady Eleanor Roosevelt, Madame Chiang Kai-shek of the Republic of China, and Madame Maxim Litvinoff of the Russian Embassy. Much of the material in this group relates to the planning of this event and includes correspondence to and from speakers, copies of speeches, lists of speakers, programs, logistical plans, and invitations.
