BIOGRAPHICAL NOTES

Gregory G. Lagakos was born in Camden, New Jersey, on August 16, 1912. He graduated from the College of William and Mary in 1935, and from the University of Pennsylvania Law School in 1938.

During World War II, Lagakos was a member of the Judge Advocate General's Department of U.S. Army. From 1942 to 1946, he served in this capacity in England, France, including during the Normandy campaign, Italy, and Greece, and as judge advocate and legal advisor to the American section of the allied mission to observe the Greek election in 1946.

After the war, Lagakos was a member of the law firm of Rappaport and Lagakos until he was made, and then elected, judge of the County Court in Philadelphia in 1965. In 1969 he became a judge on the city's Common Pleas Court and was re-elected to a second term in 1975.

Lagakos' primary activity beyond his legal career was with the American Hellenic Educational Progressive Association (AHEPA), a national Greek-American fraternal organization. He was the president of the Philadelphia Chapter in 1948; lieutenant governor and deputy district governor of Power District # 4 in 1952; and Pennsylvania state director of the AHEPA Relief Committee from 1953 to 1955. He then served as the national supreme counselor from 1955 to 1957, and was elected supreme vice president in 1978. In that capacity, he also served as national chairman of the AHEPA Growth and Expansion Committee, travelling throughout the United States to help form new chapters and increase the membership of the organization.

In addition to his many activities in AHEPA, Lagakos was a nationally prominent jurist and member of various civic, cultural, and professional organizations, part of which are represented in this collection. The following chronological outline shows a very small segment of the broad range and extent of his activities:

In 1976, Lagakos was chairman of the 23rd Bicentennial Clergy-Laity Congress of the Greek Orthodox Archdiocese of North and South America, meeting in Philadelphia, and was responsible for the implementation of many of the Congress' subcommittee programs. He was also a member of the American Bar Association, the Pennsylvania Bar Association, and the Philadelphia Bar Association.

Lagakos was married to the former Catharine Stephano of Elkins Park, Pennsylvania, and they had one daughter, Penelope. He died on July 6, 1982.

SCOPE AND CONTENT

Textual Records: This collection spans the years 1937-1989, but the bulk of the materials is concentrated between 1967-1982, and covers Lagakos' civic, political, community and religious activities. Unfortunately, there is a very little personal and family information here. The most noteworthy of the materials is in the large Series I, reflecting Lagakos' participation with AHEPA, at the local, state, and national levels. Series II focuses on his participation in numerous other community or religious activities. The records generally consist of by-laws, correspondence, directories, financial data, historical notes, meeting minutes, newspaper clippings, official publications, programs, and reports. The few personal and family materials cover the years 1976-1989 and contain biographical information, Lagakos' resume and family tree. Most of the papers are in English, although there are a few in Greek.

The textual records, except for directories, financial documents, newspaper clippings, and reference materials, have been indexed.

Photographs: The photographs had not been processed as of June 2001. They retain the same MSS 169 number as manuscripts and have been placed at the end of the manuscript collection in a separate box.

Artifacts: Five convention badges have also been removed from the records and put in the same box as the photographs, although carefully separated from them.

RECORD SERIES DESCRIPTIONS

SERIES I: AHEPA (American Hellenic Educational Progressive Association),
1937-1985, Boxes 1-14 & OS (Oversize) Folder

This big series has been divided into three subseries to reflect the major areas of Gregory Lagakos' involvement with AHEPA, where he served in numerous capacities on different levels.

SUBSERIES A: National Headquarters: General Office Materials, 1937-1982
Boxes 1-5 & OS (Oversize) Folder

This subseries contains some proceedings of AHEPA's national and grand conventions, and the Atlanta 1972 convention, held in the city where the organization was founded. There are some intriguing materials regarding Lagakos' involvement with a political controversy between two feuding AHEPA factions, the "First Party" and the Lagakos' backed "United Party" (box 1, folders 8-12). The bulk of this series is from several committees, including something called the Ten Man Bipartisan Committee, which Lagakos chaired (1977); the Membership Committee, which he co-chaired (1970-1971); and the Cyprus Aegean Affairs Committee, for which he was as the legal counselor (1974-1975). Records here consist of correspondence, directories, financial data, histories, meetings, newspaper clippings, and official publications, mostly the "Ahepan" (1968-1981). There is also Lagakos' correspondence with the president of the U.S.A., Jimmy Carter, and the Prime Minister of Greece, Constantine Caramanlis, regarding Greek-American community concern about the Cyprus-Turkey conflict in 1978 (box 3, folders 7-11). Most of the materials are in English, although there are some in Greek. Arrangement is alphabetical.

Lagakos was elected a supreme vice president at the 56th convention in August 1978. In 1979 he ran as a candidate for the post of supreme president but was unsuccessful.

This subseries includes candidacy information and election data, as well as materials on a membership drive, successfully conducted by Lagakos in 1979. The records also consist of convention materials, correspondence, with newspaper clippings, interspersed throughout the folders, directories, financial and statistical data, meeting minutes, and reports, including a report on Lagakos' activities as vice president. Most of the materials are in English, with some in Greek. The subseries is arranged alphabetically.

SUBSERIES C: Chapter & District Materials, 1965-1982, Boxes 9-14

This subseries deals mostly with materials of the Greater Philadelphia Hercules-Spartan Chapter # 26 when Gregory Lagakos was president in 1948, and Power District #4 when he was the lieutenant governor and deputy district governor in 1952. Material here contains information about district conventions, anniversaries and chapter celebrations (including AHEPA's golden anniversary Grand Ball of the Philadelphia Chapter), initiations, and installations. The largest part of the materials is correspondence (1965-1982). In addition, the records consist of directories of members, financial data, meeting minutes, and reports. Again, most of the materials are in English. Arrangement is alphabetical.

SUBSERIES A: Greek Orthodox Archdiocese of North and South America,

In 1960, Lagakos became a Knight of the Order of St. Andrew, and in 1976 served as general chairman of the Greek Orthodox Clergy-Laity Congress in Philadelphia. In 1979 he was awarded the Gold Cross of the Holy Sepulchre at St. George's Greek Orthodox Cathedral.

SUBSERIES A: Greek Orthodox Archdiocese of North and South America,
1967-1982

The bulk of this series is material about the Clergy-Laity Congress, including agreements, albums and workbooks, schedules of events, correspondence, directories, financial documents, historical notes, minutes, newspaper clippings, programs, and reports. Most noteworthy, perhaps, are Lagakos' records outlining the construction and ownership of a senior housing project, created by the St. George Orthodox Cathedral and the St. George Senior Housing Corporation in 1973. Most of the materials are in English, although there are some in Greek. The materials are arranged alphabetically.

SUBSERIES B: Other National & Community Organizations, 1963-1982,
Boxes 21-22

This small subseries includes materials of several other national or political organizations with which Lagakos was involved, in particular, the Democratic National Committee, for which Lagakos was a national treasurer (1964-1965); the National Conference of Christians and Jews, Inc., on which he served as a member of board of directors (from 1970) and was chairman of 1976 Brotherhood Week; and the Nazareth Academy, at whose Educational Advisory Board he served in 1976. The records consist mostly of correspondence, directories, and minutes. Most are in English. Arrangement is alphabetical.

SERIES III: PERSONAL MATERIALS, 1976-1989, Box 22

This tiny section contains some personal and family information, including Lagakos' resume, biography, family tree, and two certification cards. Also there is a bulletin from the University of Pennsylvania where Lagakos received his law degree in 1938. Regrettably, no materials document his private life.
