Abstract

The Chambers family of New Castle County, Delaware, and Chester County, Pennsylvania, descended from John Chambers of Yorkshire, England. They settled as farmers on "Hopyard," a sizeable farm that encompassed land in lower southern Chester County to the upper branch of the White Clay Creek in Delaware. In the latter half of the nineteenth century, several family members moved to West Grove, Pennsylvania, where three brothers formed a business distributing, among other things, grain, wool, lumber, and coal.

This collection presents the history of a family that was among the early settlers of southern Pennsylvania and northern Delaware. The collection spans from the 1700s to the mid 1900s, and contains material, such as correspondence and bills, that documents the daily lives and ventures of individuals from several generations. There are also assorted estate and legal papers, such as deeds, indentures, wills, warrants, and bonds; photographs; ephemera; travel notes; and several volumes, such as daybooks and ciphering books.

Background note

The Chambers were a family of farmers and merchants who originated from John Chambers (1662-1730), a member of the Society of Friends from Yorkshire, England. He, along with his second wife and five children, came to Philadelphia in the early 1700s and settled on a 664-acre farm called Hopyard sometime around 1720. The farm, which was utilized at the time for food and grain crops, spanned from northwestern Delaware to southeastern Pennsylvania and remained in the family for several generations. Over time, its acreage diminished as the land was sold or divided among family members. In the 1850s, a portion of the land called Hilltop became the site of the family home by the same name. By the late 1870s, the remaining farm totaled about 168 acres; but by the 1920s, since several adjoining farms had been inherited or bought, the farm's size had increased to just over 500 acres. This land was kept within the family and turned it into a profitable dairy farm named Chambers Rocks Farm.

While the family grew, the bulk of its members remained on Hopyard; however, a few descendants moved to northern Maryland or Philadelphia. Some early family members, including John Chambers's grandsons, John, Benjamin, and Samuel, joined the Delaware militia during the Revolutionary War. Notably, John and Benjamin attended school with Charles Thomson, the future secretary of the Continental Congress. John Chambers's great-grandson, John W. Chambers (1816-ca. 1868) built the Hilltop house in 1851 where both he and his wife, Mary Jane [Kemble] Chambers (1818-1906) lived for the rest of their lives.

Samuel Kemble Chambers, John W. and Mary's second son, was among those who moved off the family farm. After he graduated from Westtown School, a Quaker preparatory and boarding school, in 1861, he moved first to New Garden, Pennsylvania, and then to nearby West Grove. He enlisted in the army in 1864 and was mustered in July of that same year. He served with the 197th Regiment of Pennsylvania Volunteers. After one hundred days of service, he was formally discharged, and he returned to West Grove. Soon after, he and his brothers John J. and George R. Chambers formed Chambers Bros, distributors of wool, grain, and lumber. The name was eventually changed to S.K. Chambers & Bros., and the distribution list grew to include items such as salt, seed, and fertilizer. Samuel also achieved prominence when he founded the National Bank of West Grove, where he served as president for twenty-one years. He also established, in 1855, West Grove's Presbyterian Church. After Samuel's death, his brother John J. Chambers maintained the family store, which he managed until his own death in 1926.

In 1877, Samuel married Rebecca Lavinia Ballard (1858-1920), who had attended Putnam Female Seminary in Ohio, the same state in which she was born. While she was a strong mother to their two daughters, Mary and Helen, Rebecca was also a strong leader and served as secretary and, for a year, president of the Pennsylvania chapter of the Women's Christian Temperance Union. She was also a member of West Grove Presbyterian Church, the Independent Order of Good Templars, and the Daughters of the American Revolution.

Samuel and Rebecca's oldest daughter, Mary Ballard Chambers, inherited the family farm in 1920. Mary married Phillip Donald Folwell in 1904, and they turned the land into a profitable dairy farm that they named Chambers Rocks Farm. The farm was managed by hired farmers, several of whom raised prize-winning cattle which were sometimes shown at Harrington, Delaware's farm show. Meanwhile, the Folwells, resided in Philadelphia with their family of two sons and four daughters. They remained in the city until 1927 when they moved to Merion, Pennsylvania. A few years after her husband's death in 1955, Mary moved to an apartment complex in Merion called Merion Manor. By the early 1960s, she had moved back to Philadelphia.

Scope & content

The Chambers family papers are a modest collection of correspondence, estate and legal papers, financial material, photographs, diaries and other volumes, and ephemera. Overall, the collection spans about two hundred and sixty years, but the bulk of the

material dates from the 1840s to the 1920s. While the collection is probably most useful to family descendants doing genealogical research, it also contains useful land deeds that trace several early land transactions in Pennsylvania and Delaware. Additionally, the correspondence and financial material documents the daily lives and ventures of an early Quaker family that settled in southeastern Pennsylvania and northwestern Delaware. A brief genealogical report on the descendants of Richard Chambers (1775-1863) is available as an appendix on page 12.

This medium-sized collection has been arranged into four series. The first series (Correspondence) contains mostly mixed family letters that are arranged by date. One folder, however, contains a distinct group of letters that Samuel received from friends and family while he served in the army in 1864. The second series (Estate and legal) contains land deeds and indentures that are among the earliest material in the collection. In this series, there is also an assortment of other legal papers, wills, and related correspondence. The third series (Financial) primarily consists of certain family members' collections of household bills and receipts. There are also several volumes including three daybooks and a receipt book. The fourth and final series (Miscellaneous) contains a range of volumes, from early ciphering books to travel and personal diaries to address books. It also contains a folder of family photographs, ephemera such as calling cards and membership cards, an "Official Map of Pennsylvania" published around 1920, and a scrapbook made by Mary Chambers Folwell.

Series descriptions

Series 1. Correspondence, 1768-1957, n.d. (Boxes 1-2)

This small series of ten folders contains an array of family letters that chiefly discuss family and personal events, business ventures, personal health and affairs, and travels. Only occasionally did a writer touch upon current events and subjects, such as military preparedness, the abolition of slavery, and economic downturns. For example, in a letter from David M. Chambers to John W. Chambers dated December 16, 1838, David briefly discusses the two kinds of abolitionists with which he has become familiar: "the obstaining [sic] and the non obstaining [sic]." The difference, he wrote, is "the former consider it their duty to refrain from eating all kinds of slave produce[,] which the latter do not." Another example is a letter dated March 3, 1874, from Samuel K. Chambers to his mother Mary Jane Chambers. "The Temperance movement, is all the rage here now," wrote Samuel, who was then in Williamsport, Pennsylvania, on business, "although this town voted against [the]

Local option, there is a good deal of wiskey [sic] drank." He then mentioned that several prayer services were held around Williamsport in support.

Other than general family letters, researchers will find other groups of notable correspondence, including letters written to Samuel K. Chambers while he served in the army from July to November 1864. There are also a few scattered letters from Rebecca L. Ballard from around the time (ca. 1875-1876) she attended Putnam Female Seminary in Ohio. There are also later letters from Rebecca to various family members written on Women's Christian Temperance Union of Pennsylvania letterhead, in which she is listed as president. Finally, in Box 1 Folder 7, there are descriptive letters from Mary B. Chambers to her family while she was at Smith College in Northampton, Massachusetts, from 1900 to 1904.

Series 2. Estate and legal, ca. 1703-1946, n.d. (Boxes 2-3, Flat files 1-2)

This series contains an assortment of wills, inventories, and legal documents from and correspondence about many of the Chambers family estates, including those of early ancestors John (1662-1730) and Richard (1700-1774). There are also several folders of unsorted legal papers including bonds, warrants, indentures, agreements, and settlements.

The earliest item in this series appears to be a warrant involving John Richardson and Joseph Clayton, which was then given to John Chambers (1662-1730) by Richardson. The warrant mentions lands situate to the White Clay Creek in New Castle County, Delaware, which is presumably why it fell into Chambers's hands. There are also copies of three early legal documents, the first of which is a 1684 land patent from William Penn to John Ogle. It contains the earliest mention of the land called Hopyard, of which Ogle was the first owner. The second document is a copy of the 1720 indenture between David Lloyd, presumably the second owner of Hopyard farm, and John Chambers. At this point, when Chambers became the owner of the farm, it totaled 664 acres. The last document is a 1725 indenture recording the receipt by Richard Chambers, John Chambers's son, of 130 acres of the Hopyard farm.

This series also contains stock certificates, miscellaneous papers of Rebecca B. Chambers, land deeds and surveys, and lone wills of various family members.

Series 3. Financial, 1765-1956, n.d. (Box 4, Vols. 1-2)

The bulk of this small series is made up of personal and household receipts from several family members, including John Chambers (1730-1807), Richard Chambers (1775-1863), and Mary Jane [Kemble] Chambers. In particular, there is a folder of invoices from S.K. Chambers & Bros. to Mary J. Chambers, which document her accounts with the company at least two decades after her husband's death. There is also an account book from Sarah Black Chambers (1811-1897), the eldest daughter of Richard Chambers (1775-1863). While it contains what appear to be cash records, it also contains a diary-like entry dictated to an unidentified writer by Sarah in 1895 in which she discussed her health and family.

The folder of financial material from the Folwell family (Box 4 Folder 7) contains several notable documents relating to their dairy farm, Chambers Rocks Farm, including insurance papers, cattle transfer certificates, and the farm's articles of incorporation. There are also several later papers from Mary C. Folwell, including insurance papers and her 1956 Merion Manor apartment lease.

There are also five volumes in this series: Richard Chambers wastebook/journal/ledger, two John Chambers (b. 1780) daybooks, an unidentified daybook, and unidentified receipt book.

Series 4. Miscellaneous, 1792-1963, 2008, n.d. (Boxes 4-8, Vols. 3-4, Flat file 3)

This varied series contains images and photographs, ephemera, travel notes, a circa 1920 map of Pennsylvania, ciphering books dating from 1792 to 1794, and personal volumes from Rebecca B. Chambers, John J. Chambers, and Mary Chambers Folwell.

Most of the volumes are foldered and contained in the last four boxes of the collection. Those of Rebecca B. Chambers include her 1875-1876 notebook from Putnam Seminary and her European travel diaries of 1895 and 1900. Box 5 Folder 2 contains two appointment books/diaries of John J. Chambers dated 1882 and 1887. It also contains his "Christian Year Birthday Book" also of 1887 in which he recorded the births and death of family members and ancestors. Additionally, there are two of his appointment books/diaries from 1927 and 1928; the latter contains his own entries up to mid-August, just a couple weeks before his death. Another family member later recorded that he died in late August.

Most of the volumes are from Mary Chambers Folwell. There are eight personal diaries and one autograph book that date from before her marriage, 1896 to 1904. Her pre-1900 diaries contain interesting anecdotes about her family and life in high school. Those of 1900 to 1904 contain her personal accounts of life at Smith College. Her daily entries are interesting but broad as she recalled exams, school events, students and teachers, social events, and field trips. After her marriage, Mary continued to take scrupulous notes about her daily life and events, such as her travels and her family's move from Philadelphia to the nearby suburb of Merion. In addition, she created an inspirational scrapbook and recorded extracts from a 1918 diary of Rebecca B. Chambers. These later volumes, which date primarily from the 1930s to the 1960s, are contained in Boxes 6 to 8.

Please note that the four ciphering books from the collection have been cleaned for mold.
