**Lee Arnold, DLitt et Phil** is the Senior Director of the Library and Collections and Chief Operating Officer, Historical Society of Pennsylvania.

She lectures on her research of 18th- and 19th-century cemeteries to historical societies and other groups, and in 2016, she published a book called, "Engraved: The Meanings Behind 19th-Century Tombstone Symbols," which has sold more than 250 copies. Tammy holds a B.S. from Syracuse University in Journalism and History, and is currently pursuing a M.A. in Public History from LaSalle University.
